Constitution of M/s. Triratna Buddhist Tamang Society 2080 B.S. (2023 A.D.)

Preamble:

Shakyamuni Siddhartha Gautam was born at Lumbini of Nepal. As it is expedient to register an institution holding discussion with the individuals, institution and people of neighbourhood having faith on Buddhist religion to spread enlightenment attained by Buddha and his Buddhist philosophy, and to preserve, promote, develop Buddhist religion and propagate Buddhist religion, worship according to Buddhist religion, give preaching (Deshana) on Buddhist religion, spread widely the glory of Lord Buddha and Buddhist Philosophy, establish the statues of Buddha, reform the religious, cultural, social practice which is being followed since the ancient time according to the time and run it in well managed and effective way, preserve, promote, renovate, develop Buddhist monastery, chaitya, statue, temples, inns and other property with public importance having the historical, religious and archeological importance and preserve them for a long time with the main objective to bring into the Buddhist Philosophy-"Bahujan Hitaya, Bahujan Sukhaya" (For the happiness of many, for the welfare of many) in day to day practice in the society, so, this constitution was registered on 2080/03/20 B.S. (July 5, 2023 A.D.) remaining under Institution Registration Act, 2034 B.S. (1977 A.D.) and established the institution named-Triratna Buddhist Tamang Society, 2080 B.S. (2023 A.D.).

Chapter-1 Preliminary

- 1. Name of the Institution:-**The name of this institution shall be M/s Triratna Buddhist Tamang Society. It shall be called Triratna Buddhist Tamang Society in English. In short it may be called the TBTS.






- a) **The address of the office of the institution:-**The office of this institution shall be situated at Kathmandu District, Tarakeshwor Municipality Ward No. 1, Sangla. The office may be shifted as per the necessity after taking prior approval of the local authority of the concerned district.
- b) **Working area of the institution:** The working area of the institution shall be within Kathmandu district. It may be extended throughout Nepal as per the necessity after taking the approval of the Local Authority of the concerned district.
- c) **Commencement:** The constitution shall come into force from the date of its registration.
- d) **Existence of the institution:**
This institution shall be an autonomous, corporate body with perpetual succession, a non-profitable, non-political, non-governmental social institution. Except its objective, the institution may not earn and no consultation service with fee or without fee shall be provided.

2. **Definition of the Institution:-**Unless the subject or the context otherwise requires:-

- a. 'The constitution' means Constitution of "Triratna Buddhist Tamang Society- 2080 B.S. (2023A.D.)".
- b. "Institution" means "Triratna Buddhist Tamang Society- 2080 B.S. (2023A.D.).
- c. "Committee" means an executive committee formed according to Section 13 of the constitution.
- d. 'General Meeting' means the General Meeting and the special General meeting held as per this constitution.
- e. 'Official' means the officials of the institution.
- f. 'Rules & Regulations' means the rule & regulations framed under this constitution.

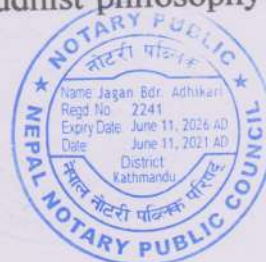
- g. 'Local Authority' means the Chief District Officer.
- h. 'Prescribed or as prescribed' means prescribed or as prescribed in this constitution, and Rules & Regulations framed under this constitution.
- i. 'Local Body' means Rural Municipality and Metropolitan City/ Sub-Metropolitan City and Municipality and District Coordination Committee.
- j. 'Council' means Social Welfare Council.
- k. 'Member' means founder member, ordinary member and life-long member.

3. **Seal and Logo:** - Without prejudice to any prevailing provision, there shall be a separate seal and logo of the institution. The seal and logo shall be as set forth in schedule 1. But if the name and the logo of the institution happens to be similar with any already registered institution, it shall immediately be amended through the amendment process.

Chapter-2 Objectives

4. **Objectives of the institution:** The following shall be the objectives of the institution.
- a. This institution shall be non-profitable, benevolent, social institution.
 - b. To spread the Buddhism and Buddhist philosophy propounded by Shakyamuni Siddhartha Gautam who was born at Lumbini of Nepal by preserving, promoting and developing Buddhist religion and to spread Lord Buddha and Buddhist religion.
 - c. To spread widely about religious activities of Buddhism, teaching of Dharma glory of Lord Buddha and philosophy of Buddha dharma.
 - d. To construct, preserve, promote, renovate, develop and manage the historical, religious and archeologically important Buddhist monastery, statue, temple, inns and preserve them for a longer period of time and run various programme to bring Buddhist philosophy 'Bahujan Hitaya,

Bahujan Sukhaiya' (For the happiness of many, for the welfare of many) into practice.

- e. To run practical programme to develop the positive thought through the means of yoga, meditation and philosophy and organize national and international level conference, seminar and conference on the subject of Buddhist philosophy.
- f. To provide financial and in-kind support to the helpless and deprived people affected by disaster people on behalf of the institution and provide necessary support to the people who are not able to do the treatment due to financial problem.
- g. To run different programme and training to encourage entrepreneurship, creativity, productive skill.

5. **Functions to be done to achieve the objectives of the institution:** The following functions shall be carried out to achieve the aforementioned objectives of this institution.

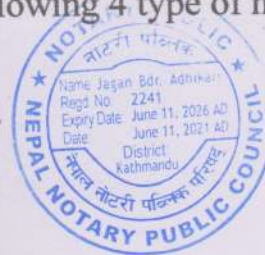
- a. The institution shall implement its objectives only after obtaining permission or license from the concerned body in accordance with prevailing laws of Nepal.
- b. It shall construct the house or take on rent/ lease which may require to the institution and purchase computer, telephone, including office items or use by taking on lease.
- c. To appoint the staffs required for the institution and determine terms and conditions of their service.
- d. To implement different programme and project for the fulfillment of the objective of the institution.

Chapter-3 Membership

6. **Classification of membership:**

This institution has classified the following 4 type of membership.

a. Ordinary member:

If any Nepalese citizen having qualification as per section 7 of this constitution submits an application for obtaining ordinary membership of the institution subject to procedure as prescribed, shall be the ordinary member of the institution.

b. Founder member:

The officials at the time of registration of this institution shall be founder members. The Founder members require to pay fees in accordance with constitution for taking ordinary or life-long membership.

c. Life-long member:

Life-long membership shall be provided under the prescribed procedure to those individuals who make special contribution for the development of institution.

d. Honorary member:

The honorary membership of the institution shall be provided to social workers and dignified Nepali citizens, to whom the institution deems capable for it by the institution but honorary members do not have voting right.

7. Necessary qualification to obtain membership:

There shall be the following qualifications for the membership of this institution.

- Being a citizen of Nepal.
- Having completed 18 years of age
- Having not lost mental balance.
- Has not proved guilty for misusing public property.
- Not having been punished in any criminal and corruption charges involving moral turpitude.

8. Condition where membership may not be obtained or not remained valid:

No individual shall be allowed to obtain membership of institution on following conditions.

- a. Non Nepalese citizen
- b. Having not attend/completed 18 years of age.
- c. Mentally sick or mad.
- d. Having proved to have misused of public property.
- e. Having got penalty in any charge with moral- turpitude and corruption.
- f. Having personal interest in the business of concerning institution
- g. Having fallen on creditor's insolvency.
- h. Having not passed one year's time of obtaining penalty proving him/her culprit by the court in the case of any types of theft, dacoit, fraud or fraudulency or have done corruption or abused or misused the property of his/her custody in an unauthorized way.
- i. If proved to have violated the code of conduct of the institution to be by a member.

9. Termination of membership:

1. No person's membership of this institution shall be valid in the following situations.
 - a. If the membership may not be obtained according to the section 8 of this constitution.
 - b. If 75% percentage of majority of members of the General Meeting of this institution passes resolution to remove from the member of this institution.
 - c. If resignation tendered by the member is approved.
 - d. If it is proved by the court that the functions and proceeding is carry out with bad intension or mala-fide intension.

- e. If any work is carried out which is prohibited by institution in accordance with this constitution.
 - f. If the membership fee remains to pay.
 - g. In case of dissolution of the institution.
2. Before declaring disqualified to any person to be appointed or to remain as the member of the institution shall be given a notice about it to such person and provide an opportunity of his/ her explanation.

10. Membership fee and procedures to distribute membership:


According to Section 6 of this constitution, membership may be obtained by the member after paying fees as mentioned below.

1. Ordinary member:

- a. If a person wants to obtain ordinary membership, shall have to pay Rs. 500/- for entry and 500/- annual fee, and then have to submit application according to the prescribed procedures, then the Executive Committee may provide membership by its decision.
- b. Such ordinary member shall have to pay Rs. 500/- for annual renewal fee.
- c. The member institution which has obtained ordinary membership shall have to renew within the last day of month of Ashad (mid-July) of every year and after that time period renewal shall have to be done after paying additional fee.

2. Founder member:

- a. The official of ad hoc committee at the time of registration of this institution shall be founder members.
- b. The founder member may obtain ordinary or life-long membership paying charges as mentioned in the constitution.

3. **Life-long member:**
 - a. Life-long membership may be provided by the decision of executive committee to the individuals who apply for it under prescribed procedure paying total Rs. 5,000/- in the institution.
4. **Honorary member:**

Honorary membership may be provide to social workers, dignified person and dignitary Nepali citizens who is deemed to be suitable by the decision of general meeting. But the honorary members do not have voting right.
5. If decision is made not to provide membership to any applicant, then information thereof shall be provided to the applicant with its reason.
6. All members have to obey the provisions of this constitution and Rules and Regulations framed under this constitution.
7. Record book of member shall be maintained separately as prescribed in sub-section 1,2,3& 4 of the institution.

Chapter-4

Provisions relating to the General Meeting, Executive Committee and Meeting

11. Formation of the General Meeting:

1. The members obtaining the membership according to Section 6 of this constitution except the honorary member shall form the general meeting of the institution. Honorary members shall be the invitee. The general meeting shall be the supreme organ of the institution.
2. The General Meeting of this institution shall be as follows.
 - a. **Annual General Meeting:**

Annual General Meeting shall be held once in a year.
 - b. **Special General Meeting:**

If 1/4 (one fourth) of members out of total members demand to call the Special General Meeting by showing by its reason, then

the Executive Committee shall have to call the Special General Meeting compulsory at least within 7 (seven) days. But within the 6 months of holding of General Meeting or the Special General Meeting, the Special General Meeting may not be held again.

3. The first Annual General Meeting of this institution shall be held within two months from the completion of fiscal year of incorporation of institution and thereafter the Annual General Meeting shall be held within 3 months from the completion of fiscal year.
4. There shall be provided a notice compulsorily to all ordinary members by stating agenda of discussion, date and venue of meeting at least before 15 days for the Annual General Meeting and at least before 7 days for the Special General Meeting of this institution.
5. If the General Meeting or the Special General Meeting called according to sub-section 4 could not be held due to lack of quorum according to Section 18, then another General Meeting or the Special General Meeting shall be called again by giving notice at least before 7 (seven) days.

12. Functions, duties & rights of the General Meeting:

Following shall be the Functions, duties & rights of the General Meeting.

- a. To pass annual budget, plans and programs presented by the Executive Committee.
- b. To approve annual auditing by holding discussion on the report received from the auditor; and to direct the Executive Committee by doing discussion to take back arrear amount which seems from the report of the auditor; and to make it regularized and clear it by recovering those irregular amounts.
- c. To appoint auditor for the coming year

- d. To provide necessary directions to the Executive Committee by evaluating the functions of the institution and annual work progress report of the institution.
- e. To elect office bearers of the Executive Committee remaining under the procedure of constitution on a condition of completion of tenure of office bearers of Executive Committee of institution.
- f. To approve Rule, Regulations and amendment of constitution presented by Executive Committee.
- g. To provide the honorary membership.
- h. To approve the functions and proceeding done by the Executive Committee considering its appropriateness and in the interest of the institution.
- i. To grant permission as per necessary presented by the Executive Committee about posting, remuneration, allowance and other facilities of the employees to be borne by the institution from its own internal resources.

13. Formation of Executive Committee:

1. There shall be formed a 9 (nine) members Executive Committee elected from the members of the General Meeting.

2. The tenure of the Executive Committee shall be of 2(two) years.
3. If the post of any member of the Executive Committee lies vacant before holding the Annual General Meeting, then it can be nominated member by the Executive Committee for remaining tenure of the member of the Executive Committee. Tenure of the member appointed

in this way shall only be to the remaining tenure of that member by whom the post becomes vacant and by which he/she is appointed.

4. Meeting of the Executive Committee shall be called by the president as per requirement of the Executive Committee. But, if 51% of members out of total members demand, then the president shall immediately call the meeting of the Executive Committee.
5. The meeting of the Executive Committee shall not be held without presence of at least 51% of office bearers out of total office bearers of the Executive Committee.
6. Meeting of the Executive Committee shall be presided by president of the Executive Committee. In the absence of president, meeting will be chaired by the vice-president. In the absence of vice-president, meeting shall be presided by the senior member selected by members attending the meeting.
7. In the meeting of the Executive Committee, decision of the majority shall be valid; and in case of tie of vote, the president may cast the decisive vote (casting vote).
8. Agenda discussed in the meeting of the Executive Committee shall be maintained recording it in a separate minute book, all meeting attending members shall have to put signatures on it. But one who dissents on the decision shall have to put on signature by making remark.
9. All the functions to be done by the association shall be done by the decision of the Executive Committee.
10. Whatever may be written in above sub-section, yet any function, which is allowed to do by the Executive Committee, if all office bearers of the Executive Committee agree in writing, then such function may be done without holding meeting by attaching such agreement in the minute book. And the agreement as mentioned above will be regarded as the decision of the meeting of the Executive Committee.

14. Functions, duties & rights of the executive committee: The following shall be functions, duties & rights of the Executive Committee.

1. To present upcoming annual programs and estimated budget of association to the General Meeting after preparing it.
2. To implement and cause to be implemented the decision of the General Meeting by following the provisions of constitution.
3. To run the programs which is in the interest of the Institution.
4. To be responsible to the General Meeting.
5. To use and utilize the available means and resources to the utmost to achieve the objectives of the association.
6. To perform the work of the institution, to make action plan, accumulate the available resources, supervise and monitor its implementation.
7. To cause to maintain the property and fund of association well secured; and operate it by opening bank account.
8. To formulate regulation regarding the service of employee and its terms and conditions, and benefit of employee, to implement Regulation after approving from General Meeting.
9. To form sub-committee, other committee and advisory committee from capable individuals for their own working tenure to fulfill the objectives of the association; and allocate functions as per requirement.
10. To play leading role of the association.

15. Designation can be given-up: President may tender his/her resignation before the Executive Committee through Vice-President, and Vice-President and other office bearers may tender resignation before the President.

16. Other committee:

1. The Executive Committee may form other committees or sub-committees as per requirement for operating the function of the

2. The functions and tenure of sub-committees shall be as prescribed by the Executive Committee.

Chapter-5

Functions, duties and rights of the office bearers

17. Functions, duties and rights of the office bearers:-The following shall be the functions, duties and rights of the office bearers of the Executive Committee.


1. Functions, duties and rights of President:

- a. To preside the meeting of the Executive Committee and Meetings.
- b. To cast the casting vote.
- c. To represent or fix representative on behalf of institution.
- d. To take leadership of the institution.
- e. To provide directions to the secretary to call the meetings as per requirement.
- f. To divide the functions to other office bearers and members.
- g. To certify record.
- h. To approve the resignation of the members of the institution and approve the membership.

2. Functions, duties and rights of Vice-President:

- a. To assist the president.
- b. To fulfill responsibility given by the president.
- c. To do all functions in the absence of the president.
- d. To carry out other work as prescribed by the Executive Committee.

3. Functions, duties and rights of Secretary:

- a. To run and supervise the secretariat of the institution.
- b. To call the meeting of the executive committee and other meeting according the direction of the president.
- c. To keep the record of the institution safely.
- d. To complete other responsibilities assigned by the president.

4. Functions, duties and rights of Treasurer:

- a. To supervise and run the fund of the institution.
- b. To present annual program and budget in the general Meeting.
- c. To maintain the account accurately.
- d. To audit the annual account regularly.

5. Functions, duties and rights of Members:

- a. To show active participation in the meeting of the executive committee.
- b. To play constructive role to the functions of the institution.
- c. To carry out the work according to the constitution, programme and objective of the institution.
- d. To supervise the institution and submit to the committee and exchange the good advice and suggestion.
- e. To carry out the work under own responsibility as per the work division made by the institution.

18. Quorum:

1. No function and proceeding of the General Meeting shall be done without being presence of 67% (sixty seven) percentage of ordinary members out of total members.
2. But the General Meeting called again as stated in sub-section (5) of Section 11 of constitution, if 51% out of total members, becomes present, then there shall be no obstacles to hold the meeting.

Chapter-6 Financial Provisions

19. Fund of the institution:


1. There shall be its own separate fund of this institution, and in that fund, there shall be deposited the following obtained amounts.
 - a. The amount of fees obtained from membership entry fees and membership fees.
 - b. The amount received for grant and assistance given voluntarily by any person.
 - c. The amount obtained as aid/support from foreign institution, individual or international institution.
2. Prior approval shall be taken from Government of Nepal, Social Welfare Council if financial assistance or grant is to be taken from the foreign institutions or persons.
3. The bank account shall be operated in a local bank by depositing the amount which is received by the institution.

20. Account operation:

The account shall be operated by the joint signatures of president and treasurer (compulsory) of the institution. Provisions shall be made in accordance with prevailing Act, and Rules, there shall be maintained the record of the expenditure.

21. Process to spend the amount of the fund: The following processes shall be followed to spend the amount deposited in the account of the institution.

- a. No expenditure may be done without approving the annual budget, plan and program of the institution.
- b. The amount of the fund may be spent by remaining under the budget and program as passed by the General Meeting.
- c. Financial report of expenditure made from the fund of the institution must compulsorily be submitted in the General Meeting.

- d. While spending the amount of the fund, it shall be spent as per the prescribed process.

22. Account and auditing of institution:

1. The account of income and expenditure of the institution shall be maintained clearly according to prevailing laws.
2. The auditing of institution shall be done by the registered auditor according to prevailing laws.
3. If Government of Nepal or Local Authority wants to inspect itself or make to inspect by sending its subordinate personnel, may examine the account of the institution at any time.
4. The auditor or institution shall be appointed by the General Meeting. But auditor shall be appointed by the Executive Committee until the First Annual General Meeting is not hold.
5. The audit report and details of annual work progress of the institution shall be submitted one copy each to the Local Authority, Local Level, Social Welfare Council and concerning body.

Chapter-7

Provisions relating to election, motion of vote of no confidence and amendment of the constitution

23. Provisions relating to election:

1. For the purpose of election of the Executive Committee, there shall be formed an Election Committee not exceeding 3 persons on the consensus of the Executive Committee.
2. The Election Committee shall manage the election procedures by itself remaining within the ambit of prevailing laws.
3. If there arise any dispute relating to election, then the decision made by Election Committee shall be final.
4. The Election Committee shall be dissolved automatically the next day after completion of election.

24. **Qualification to be a candidate:** To be a candidate of the Executive Committee, there must be the following qualifications.

- Being a member as per section 6.
- Not being disqualified according to section 8.
- Having remained membership at the prescribed time.

25. **Motion of vote of no confidence:**

- The motion of vote of no confidence must be registered in the institution in written form by clearly maintaining the following procedures against whom it is brought by office bearer.
 - It must be written by using civilized words in Nepali language.
 - The agenda of motion must be clear and practical/pragmatic.
 - At least $\frac{1}{4}$ (one fourth) members out of members of the General Meeting must put signature by clearly stating name, surname including address of the members.
- The notice shall be provided to all of the members according to Section 11(4) of the constitution for holding the General Meeting or Special General Meeting for motion of vote of no confidence registered according to sub-section 1 in the institution by clearly stating, agenda, meeting venue, date including time of the General Meeting or Special General Meeting to all of the office bearers and members of the General Meeting of institution.
- The procedures of discussion on the motion of vote of no confidence.**
 - The person who presides the General Meeting shall grant permission to present the agenda as per sub-section (1); and one of the member who has presented that agenda shall present his/her opinion before the meeting by stating the reason to bring the motion of vote of no confidence.

- b. Only after presentation of opinion by the member in favor of the motion of vote of no confidence in accordance with sub-section 3(a), then the president may grant permission more than three members to express opinion who want to express their opinion on that motion.
- c. The person who presides the meeting shall grant permission for opportunity to present clarification to those office bearers against whom the motion of vote of no confidence is brought according to sub-section (1).

4. **Decision on the motion of vote of no confidence:**

1. After completion of expressing opinion on the motion of vote of no confidence, the person who presides the meeting shall declare decision of vote of no confidence that whether the motion of vote of no confidence is in favor or against by following any of the following procedures to make the decision.
 - a. Separating the group, one group which express their opinion in favor of the motion of vote of no confidence; and another group which express against it, or,
 - b. Making secret voting of the members of the General Meeting in favor of motion or against it.
2. The motion of vote of no confidence shall be passed by 2/3 (two/third) majority of the total members of the General Meeting. If such motion is passed, then the proposed person in favor of it shall automatically be removed from the post.
3. No another resolution may be brought again on such person without completing 6 months of election or without completing 6 months of failure of motion.

26. **Amendment of the constitution :** Only after approval made by 2/3 (two/third) of members out of total members of the General Meeting, then it

must be forwarded with recommendation to the Local Authority for amendment or repeal of any section of institution. Only after obtaining the permission of the Local Authority, then any Section of the constitution shall be regarded as amended or repelled.

27. Power to frame rules:

1. The institution may frame necessary rules in order to run its works; and the rules shall be implemented after getting approval from the General Meeting, and the information of it shall be given to the Local Authority.
2. Remaining under this constitution and rules framed under this constitution for the purpose of implementation of objectives and execution of the work of the institution, the Executive Committee may implement it by formulating regulation relating to provision of employee and financial administration. Such regulations shall be approved by the General Meeting.

28. Employee's Provision:

- a. For running of the daily work of the institution and operation of plan and program, and for the creation of post of employee, remuneration, and allowance and other facilities and terms and conditions of the employee, the procedures shall be as prescribed.
- b. If the situation comes for the institution to keep foreign advisor or volunteer to operate program and to implement achieving foreign assistance then their period of work, providing service, justification of work, facility and qualification description shall have to be submitted to the Local authority, District Development Committee and Social Welfare Council.

29. Dissolution of institution :

1. If the General Meeting deems necessary, then it may dissolve the institution by passing the special resolution.

2. The General Meeting may appoint one or more than one auditors to audit the account of the institution and one or more than one liquidators for dissolution of institution while passing the resolution of dissolution by the General Meeting according to sub-section (1).
3. The remuneration of the auditors and liquidators appointed according to sub-section (2) shall be as prescribed by the General Meeting.
4. If the institution is dissolved by any cause, then after clearing the liabilities of the institution, remaining total assets of the institution shall be the assets of Government of Nepal.

30. Interpretation:

Power to interpret this constitution and Rules and Regulations framed under this constitution shall be vested to the Executive Committee.

31. Secrecy must not be disclosed:

Any office bearer or members of this institution may not commit any work against the interest of the institution. The office bearer of Executive Committee or members of the General Meeting may not use uncivilized or vulgar words in the meeting or General Meeting.

32. To be according to Act:

Matters not mentioned in this constitution shall be in accordance with the laws and matter inconsistency with the institution registration Act, Rules and Prevailing Laws, shall automatically be inactive to the extent of inconsistency.

33. Following of directions:

To follow the directions given by Government of Nepal or Local Authority at time to time shall be the duty of institution.

34. Ad-hoc committee:

1. The Ad-Hoc Committee which is formed to register this institution shall call the General Meeting within 6 months from the date of registration of institution according to the constitution; and shall hold the election of
